Addresses gaps in access for underserved communities and Medicaid enrollees



The Maryland General Assembly convened on January 8, 2025 in Annapolis and will be in session for 90 days, or until April 7, 2025. While it will be a challenging session for legislators and advocates, MDAC looks to its broad network of partners and stakeholders to continue to move forward and build on collective achievements from previous sessions with <u>legislation that addresses</u>, expands, and improves equitable access to dental care for Marylanders. Legislation continues to be introduced and MDAC will continue to monitor activities.

## Johns Hopkins Hosts Global Oral Health Symposium MDAC on panel addressing Maryland oral health issues and achievements

The 2025 Global Oral Health Symposium, March 27-28, 2025 in Baltimore, will bring together experts from oral health, global health, and medicine to explore

the importance of integrating oral health into broader global health systems. Engaging keynote speakers, panel discussions, and interactive sessions will focus on health equity, access to care, and cross-disciplinary collaboration.



The event will kick off with a session entitled "Perspectives from Baltimore: Local to

**Global - Contributions to the Oral-Systemic Debate,**" which will include a panel of well-known and active stakeholders to discuss oral health in Maryland. The panel will include Lois Cohen of the Paul G. Rogers Ambassador for Global Health Research; Eleanor Fleming, Director of Health Equity Research and Innovation at the University of Maryland School of Dentistry; Mary Otto, Journalist & Author of "Teeth: The Story of Beauty, Inequality, and the Struggle for Oral Health in America," and Mary Backley, Chief Executive Officer, Maryland Dental Action Coalition. The panel will be moderated by Dushanka Kleinman, Professor at the University of Maryland School of Public Health. Debony Hughes, DDS, Maryland State Dental Director, will also be a featured on a panel later in the day, "From State to Global Perspectives."

The program will explore the interaction of global health and oral health bringing together experts to discuss:

# New Report: Dental Provider Participation in Maryland Healthy Smiles Dental Program

Maryland Department of Health Report Issued Pursuant to HB 290/Ch. 377 of the Acts of 2023

Pursuant to House Bill 290, (Ch. 377 of the Acts of 2023), the Maryland Medical Assistance Program, within the Maryland Department of Health, is required to submit a report that studies dental provider participation in the Maryland Healthy Smiles Dental Program. The report includes sections, and relevant data, that

address Medicaid Dental Care Access and Provider Participation; Administrative Processes Relating to Initial Enrollment and Renewal of Providers in Maryland Healthy Smiles; Incentives to Encourage Provider Participation in Maryland Healthy Smiles; Stakeholder Engagement; and Conclusions and Next Steps.

## **Research Emphasizes Link Between Oral & Mental Health** *Underscores significance of bidirectional connection*

As reported in **Decisions in Dentistry**, a recent study published in *Translational Psychiatry* cites an increasing body of evidence highlights a link between mental health disorders — such as anxiety, depression, stress — and oral health issues such as periodontal diseases, tooth loss, and chronic pain. Mental health challenges often contribute to poor oral hygiene habits, higher levels of inflammation, and increased risk for dental disease. On the contrary, oral health problems including persistent dental pain can exacerbate feelings of anxiety and depression, directly impacting patients' quality of life.

Oral health professionals can make a difference by creating an open, judgmentfree environment where patients feel comfortable discussing their challenges, including anxiety about dental visits or stress affecting their oral health habits. Looking for red flags such as poor oral hygiene, bruxism, or signs of self-neglect, may identify underlying mental health concerns.

In addition, partnering and integration of care with mental health providers can be transformative. Establishing a referral network ensures patients receive the comprehensive care they need. For example, a patient with severe bruxism linked to stress may benefit from both a night guard and cognitive behavioral therapy to manage the root cause.

Preventive education is another key strategy. Oral health professionals can emphasize how oral health routines are part of a broader strategy to maintain mental and physical health. Studies show that small wins in oral health can have a positive ripple effect, boosting confidence and mental resilience.

## Medicaid's Role in Small Towns and Rural Areas

Georgetown University McCourt School of Public Policy Center for Children and Families issues report

One-fifth of people in the United States live in areas that are classified as nonurban. Residents of rural areas and small towns face additional challenges accessing needed health services



compared to residents of metro areas for a variety of reasons including acute

provider shortages, limited connectivity, and long distances to travel to access care, often without reliable public transportation options. Residents of rural areas also have worse health outcomes, including higher maternal and infant mortality rates; higher mortality rates from heart disease, cancer, and stroke; and higher rates of mental illness and overdose deaths. In addition, residents of rural areas and small towns have lower incomes on average than people living in metro areas and less access to employer-sponsored health insurance, meaning that public coverage such as Medicaid and the Children's Health Insurance Program fill an even more critical role in these areas than in other areas of the country. While uninsured rates have come down significantly since passage of the Affordable Care Act, they remain higher in small towns and rural areas than in metro areas.

Cuts to federal Medicaid funding and other changes to Medicaid being contemplated in Congress will cause harm everywhere but are more likely to cause greater harm to rural communities and small towns than metro areas.

"Since 2019, the number of active dentists across the state has decreased from 4,148 to 3,917. This statewide decrease is also linked to COVID-19, which impacted all providers, not just those who accept Medicaid. Meanwhile, the number of dentists enrolled in Healthy Smiles continued to increase, going from 1,567 in CY 2019 to 1,912 in CY 2023."
